THE VICTIM SUPPORT UNIT

MISSION OBJECTIVE

The Victim Support Unit of Jamaica, operated by the Ministry of Justice is intended to assist persons against whom certain offences have been committed. Victim Support Unit is committed to the best interests of victims of crime by actively supporting them, identifying their needs and advocating their rights.

STRUCTURE

The Unit is headed by a Senior Coordinator, supported by a Coordinator, thirteen Parish Coordinators and several Social Workers.

The Victim Support Unit is also assisted by groups of volunteers selected from various districts within the parishes.

COMMUNITY FOCUS

Parish Officers conduct the work with the assistance of volunteers selected from within communities. In this way the Unit offers the citizens the opportunity to become more involved in the Justice System.

WHAT DOES THE UNIT OFFER?

Services offered by the Unit are free, confidential, and of the highest quality. These include:

1. EMOTIONAL SUPPORT

- Mediation & Counselling
- Support during & after case disposition

2. CRISIS INTERVENTION

These services should be provided ideally, on a twenty-four hour basis and should for the most part be available across the island, especially in cases where the victim may require attention:

- Telephone counselling
- On-the-scene-response
- Home visits; or
- 'Walk-in' service.

3. TECHNICAL SERVICES

- Advocacy (Referrals)
- Training for professional and allied personnel working on victims' issues

VIOLENCE PREVENTION INITIATIVE

Much of the function of the Victim Support Unit is violence prevention ,which includes:

- Sensitization of society of the social and psychological impact of crime
- Providing information to crime victims about their rights
- Promotion of crime prevention tips
- Operational strengthening of networking among victim support organizations.

WHO BENEFITS FROM THE VSU?

Persons who fall within the following categories can benefit from the VSU:

- Persons against whom criminal offences have been committed, e.g. rape, wounding, etc..
- Victims of arson
- Victims of serious domestic and community disputes
- Victims of human rights abuses
- Family members of a murdered victim
- Children used by older persons to commit crimes

THE WORK OF THE VOLUNTEER

In order to promote social solidarity, the programme offers the opportunity for those that are strong to help those that are vulnerable and/or victimized. In this pursuit we seek well-thinking persons within communities to serve as volunteers.

Volunteers:

- Counsel victims
- Mediate
- Assist victims accessing help for medical purposes if necessary
- Explain elements of the criminal justice system to the victim
- Inform victims of agencies that are available to help them in different ways
- Refer victims to the Victim Support Unit in their parish

CHARACTERISTICS OF A VOLUNTEER

A volunteer should be:

- Accessible to the victims in the place in which they are serving
- Capable of high levels of confidentiality
- Non-judgmental
- Compassionate and patient
- Willing to be trained
- Willing to serve
