Please note:

Ground zero 68, the body of an unidentified male who was collected by Madden on the 29/5/2010 from Taylor's Funeral Home is now found entered as a case of Murder at Major investigation Taskforce.

He is identified to be Mark Antony Smith 36 yrs old caretaker of 172 King Street, Kgn, by his mother Emily Smith of the same address. Post-mortem was conducted by Dr. Prasad at Spanish Town Funeral Home on the 17/06/2010 during which one bullet fragment was recovered from his body and he as since been buried on the 04/07/2010 in Mango Valley, Common District, St. Mary.

However, there are three (3) cases marked with asterisk (\*) that special note should be taken of as follows:

\* GZ 47, Sanjay Harrison of Myers Street, Kgn 12, was killed at Myers Street Jones Town was post-mortem at Norman Road on the 04/07/2010

\* GZ 73, Carlene McKenzie 47 yrs old of 25 ½ Little King Street Kgn 14 who was diagnosed as a H.I.V patient was post-mortem at Spanish Town Hospital Morgue on the 05/07/2010

\* GZ 64 A, Errol Mitchell 49 yrs old of 89 ½ Mark Lane who was shot and killed along Mark Lane Kgn was post-mortem at Spanish Town Hospital Morgue on the 06/07/2010
